2. Ministry of Internal Affairs and Law invites Open Competition Bidding from Eligible Bidders for the Supply and Delivery of 4WD Fire Fighting Vehicle under National Competition Bidding Procedure. 3. The Bidders Must Download the bidding document through e-GP II Portal of PPMO websites www.bolpatra.gov.np/egp before 2077/06/30 (15th October 2020)
4. Bids must be submitted electronically through e-GPII of PPMO website www.bolpatra.gov.np/egp. The bidders shall pay non refundable fee as specified above in Ministry of Internal Affairs and Laws Ministry Code 3140013011, TAS Account No. 10000201010001, at Financial Controller General Office Revenue Head 14229, Bank Name:- Rastriya Banijya Bank, Biratnagar, Morang and submit scanned electronic copy of the bank receipt along with the all electronic bid files.
5. The bid must be submitted before 12:00 hour noon of 2077/06/30 (16th October, 2020). The accepted e-bid shall be open in the presence of the bidders representatives who choose to attend at 14:00 hours on the last date of bid submission. Non-attendance of any or all the Bidders representatives shall not hinder the opening of the bids.
6. Bids must be accompanied by bid security amount as stated in above table either in the form of bank voucher confirming cash deposit in Ministry of Internal Affairs and Law. Office Code:- 3140013011, Account no - 2120100202030000, Pradesha Lekha Niyantarak Karyalaya, Pradesha no.1, Dharuti Khata at Rastriya Banijya Bank, Biratnagar or a bid security issued by a commercial bank approved by validity for minimum of 120 days as prescribed format counting from the date of bid opening.
7. The bidder must submit the original copy of their e-bids within 7 days of last day of bid submission deadline.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
