1. Government of Nepal has allocated funds to cover eligible payments under the Contract for **Supply and Delivery of disaster find and rescue equipments (IFB NO.: MOIALI/NCB/G-02(079-80)**. Bidding is open to all eligible Bidders.
2. The Ministry of Internal Affairs and Law, Koshi Province, invites *electronic* bids from eligible bidders for the procurement of **Supply and Delivery of disaster find and rescue equipments under National competitive bidding procedures specified in Public Procurement Act and Regulations**.
3. Pre-bid meeting shall be held at Ministry of Internal Affairs and Law, Koshi Province at **13:00 hours on 2080/01/10 (23rd April 2023)**.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Ministry of Internal Affairs and Law, Koshi Province, Biratnagar** or may visit PPMO egp system www.bolpatra.gov.np/egp.

6. Electronic bids must be submitted to the office **Ministry of Internal Affairs and Law, Koshi Province, Biratnagar** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours on 2080/01/19 (2-05-2023)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 2080/01/19 (2-05-2023)** at the office of Ministry of Internal Affairs and Law, Koshi Province, Biratnagar. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,60,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
